Fire safety information for residents living in flats operating evacuation strategies



We are committed to ensuring the safety of the Greater Manchester community through our prevention, protection, and response activity. We work closely with housing providers and managing agents to support fire safety in blocks of flats so that buildings are safe and residents can feel safe.

This booklet contains important information about fire safety including:

- What to do if you have a fire or become aware of a fire.
- Fire safety advice in your flat.
- Fire doors and why they are important.
- What you can do to help keep your building safe.

For your own safety, it is important to understand what to do in the event of a fire, whether it's in your flat or somewhere else in the building.

Your building operates an evacuation strategy.

This means that if there is a fire somewhere else in the building you must evacuate even if your flat does not seem to be affected. Failure to evacuate the building upon hearing the fire alarm puts you at serious risk in the event of a fire and could put firefighters at risk.



If the fire alarm sounds, you must take the following immediate actions:

- ✓ Get everyone in your flat out.
- ✓ Make sure your flat door closes behind you.
- ✓ Leave the building using the emergency exit routes and stairs provided (don't use the lift).
- ✓ Get out, stay out, call 999.



If you feel that you would be unable to evacuate the building without assistance you should contact your housing provider or the managing agent for the building.

What to do when you are outside the building

You should move away from the building and go to the assembly point and wait for the fire service to arrive. Please do not leave before we arrive – it is important that we know how many people have evacuated the building and you may be asked for details about where you live. If the fire was in your flat tell them where your flat is in the building, where in your flat the fire started and what is on fire.

It may take some time for firefighters to tackle the fire – you won't be able to go back into the building until the fire has been extinguished and it is safe. You should not try and re-enter the building until told it is safe to do so by a firefighter.

You may be directed to another building where you can wait until it is safe to return to the building.

What to do if you cannot leave your flat or the building

If you hear the fire alarm and you cannot leave your flat move to a room where you think you will be safe and call 999. Keep the door to the room closed and use towels or bedding at the bottom of the door to stop any smoke getting in.

In high rise blocks of flats the law requires a Secure Information Box to be installed at the building with information that GMFRS can use if there is a fire. The Secure Information Box can be used to record details of the location of residents who cannot evacuate the building without help. This information can only be included in the Secure Information Box with your consent. Firefighters will use this

information to identify flats where they need to provide evacuation assistance to people, or to perform rescues.

When you phone 999 you should tell the control operator that you cannot leave your flat and the reason why – this information will be passed to firefighters at the building.

What to do when phoning 999

If you have a fire in your flat or become aware of a fire somewhere else in the building, you should always call 999 and ask for 'Fire'.

When you dial 999, the first person you speak to is an operator who will ask you which service you need. When you ask for 'Fire' you are immediately transferred to our control centre with specially trained staff who will ask you for information and send firefighters to help.

Listen carefully to the control operator - the first thing they will ask you for is the address. Give them the building name, address and postcode and then the flat number and floor of your flat.

Once you have provided the address and told us there is a fire, fire engines will be sent to the building. You will be asked more questions so that firefighters can be passed the information they need when they arrive. Try and stay calm and answer any questions as clearly as you can and stay on the line until the control operator ends the call.

If you have a fire or there is smoke in your flat you should:

- ✓ Alert anyone else in your flat.
- ✓ Close the door to the room where the fire is.
- ✓ Get out of your flat – make sure the flat door closes behind you.
- ✓ Call 999 and ask for 'Fire'.
- ✓ Leave the building using the stairs if you can.



If you have a fire or there is smoke in your flat you should not:

- ✗ Try and fight the fire - you could be injured.
- ✗ Stop to collect belongings.
- ✗ Go back into your flat.
- ✗ Use the lifts – firefighters may need to take control of them.
- ✗ Re-enter the building until told it is safe.



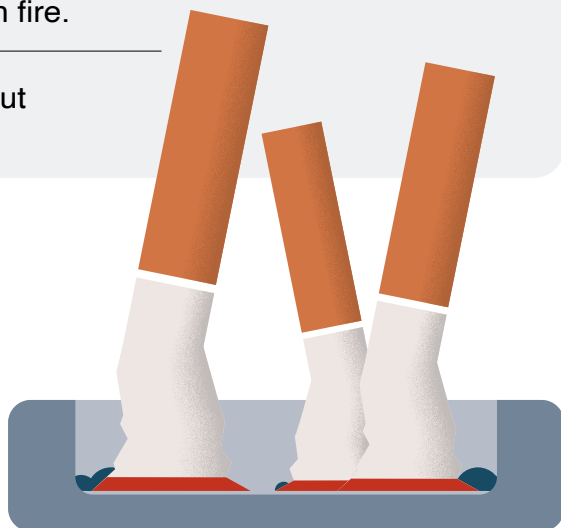
Staying safe in your flat

The best way to stay safe is by taking steps to prevent a fire happening in your home. Most fires in people's homes are caused by cooking, smoking or electrical items – by taking some simple steps you can reduce the risk of a fire starting – this protects you, your family and your home.

How to prevent a fire



- ✓ Keep tea towels and clothes away from the cooker and hob.
- ✓ Keep matches, lighters and candles out of reach of children.
- ✓ Unplug appliances when you're not using them, they are fully charged, or when you go to bed.
- ✓ Always use candle holders and keep candles out of draughts and away from curtains and other materials that can catch fire.
- ✓ Always put cigarettes out properly in an ashtray.



Never:



- ✗ Leave cooking unattended.
- ✗ Smoke in bed.
- ✗ Overload plug sockets or extension leads.
- ✗ Leave appliances on when sleeping or when you go out – this includes washing machines, dryers and dishwashers.
- ✗ Leave candles unattended.
- ✗ Leave e-bikes or scooters in your hall and never charge them overnight or when you are out.

Balcony safety

If you have a balcony it is part of your home, so enjoy it safely.

You should never:



- ✗ Use barbecues, chimineas, fire pits or any other form of open fire on a balcony.
- ✗ Store or set off fireworks or flares on your balcony.
- ✗ Store flammable materials on your balcony.
- ✗ Throw cigarettes off your balcony – they can cause a fire on someone else's balcony. Use a suitable ashtray and dispose of the contents safely.

Smoke alarms save lives. Make sure you have at least one smoke alarm in your flat and it works - test it at least monthly.



All homes should have at least one smoke detector. If your flat is on more than one level you should have a smoke detector on each floor.

If you rent your home your landlord must provide a smoke alarm in your home.

You should test your smoke alarm at least monthly, by pressing the button until it beeps. It is a good idea to set a reminder on your phone or a smart speaker if you have one.

If you press the button and there is no sound, you may need to change the batteries or the smoke alarm may need replacing.

If your smoke alarm goes off by mistake, do not take out the batteries. Just wait for it to stop. Many alarms have a hush button that can be pressed to temporarily silence an alarm.

Smoke alarms usually need replacing after ten years. If any of your smoke alarms have a one-year battery, you must change them every year. Only take out the battery when you need to replace it.

If you hear a neighbour's smoke alarm, don't ignore it but alert the resident. If they don't respond, call 999 and ask for 'Fire'.

Fire doors – protect you and your neighbours

Fire doors are important in flats to protect everyone if there is a fire. In a block of flats lots of the doors will be fire doors – this includes your flat front door and doors in corridors, landings and on the staircase.

Fire doors are designed to stop fire and smoke spreading.

Flat front doors

Your flat front door is a fire door and is there to make sure that if you do have a fire in your flat the fire and smoke won't spread into the corridor. New laws mean that your housing provider or the managing agent for the building must carry out checks on fire doors to make sure they are not damaged.

Your front door should:

- Close on its own – fire doors are fitted with self-closing devices which can be fitted to the top of the door or be fitted within the frame.
- Not have big gaps between the door and the door frame.

The law says your housing provider or managing agent must check your flat front door once a year. They will need to inspect the door from both sides and make sure that it closes on its own and there is no damage.

You must not:



- ✗ Change your front door without permission – if you rent, check with your landlord and if you own your flat your lease will explain what permission you need. You may need to obtain building control approval to change your front door and if you don't you could be breaking the law.
- ✗ Remove or damage the self-closing device on your door.
- ✗ Remove or paint over any strips or seals around the door.
- ✗ Drill any holes in the door – for example to fit a spy hole, change the letterbox or fit a new doorbell.

Fire doors in communal areas

There will be fire doors in other areas of the building, this includes doors in corridors and landings, the doors onto the staircase and doors which provide access to bin rooms and plant rooms.

Fire doors in communal areas should always:

✓ Be marked as fire doors – this is normally a blue circle that says 'Fire door keep shut'.

✓ Close behind you.



Fire doors in communal areas should never:

✗ Have big gaps between the door and the frame.

✗ Have any visible damage – for example broken glass, holes, cracks or splintered wood.



You must not:

✗ Wedge open doors which are fire doors.

✗ Damage the door, the door frame or the self-closing device – you could be committing a crime if you do.



The law says your housing provider or managing agent must check the fire doors in communal areas every three months.

If you see a fire door wedged open, please close it and if you spot damage to a fire door report it to your housing provider or managing agent.

How you can help keep your building safe

All residents can help to keep their neighbours and building safe for everyone.

Always:

✓ Report damage to fire doors to your housing provider or the managing agent.

✓ Check before doing any work in your flat that it won't affect the fire safety in the building.

✓ Allow access to your flat for the front door to be checked.



Never:

✗ Obstruct the communal areas, stairs, corridors and landings as these will be escape routes for the building.

✗ Prop open fire doors in communal areas.

✗ Store prams, bikes or mobility scooters in corridors.

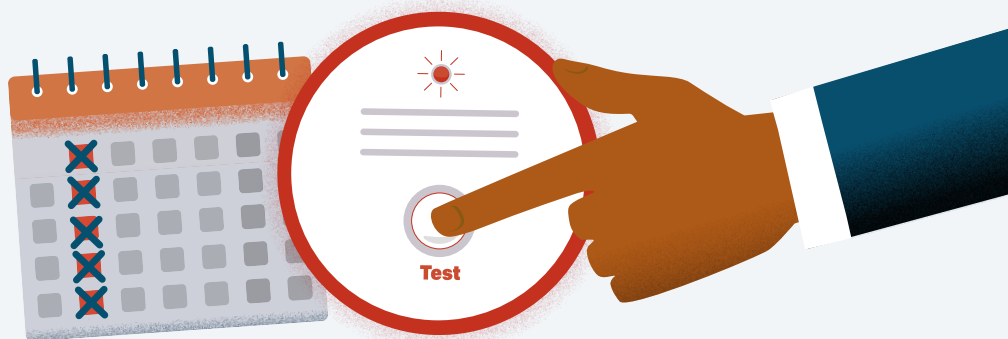
